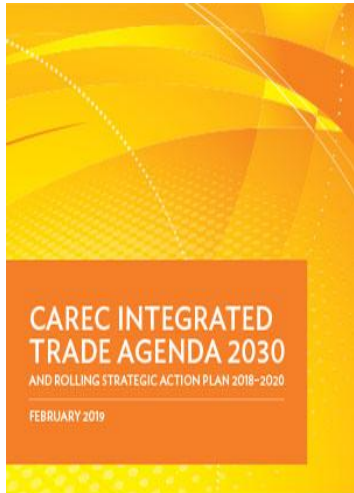

# Regional Transit Development under CAREC



- **CAREC Integrated Trade Agenda 2030** supports development of effective transit facilitation schemes
- **CAREC Customs Cooperation Committee** includes regional transit development in its priority areas of work
- Transit trade remains crucial in Central Asia noting most are **landlocked countries**
- CAREC region as a vital link to **diversify transit routes between Asia and Europe** (i.e., Middle Corridor)
- Need to strengthen **regional cooperation** to address transit facilitation challenges and gaps

## CATS/ICE Principles

- ✓ **Sound legal framework** which allows for data exchange with other entities and countries
- ✓ **Simple and speedy** treatment and harmonizing customs control **procedures**
- ✓ **Minimum documentation** and formalities
- ✓ The utilization of **comprehensive transit guarantees**
- ✓ **Non-discrimination** and freedom of transit

# Opportunity to Improve the Existing CAREC Transit Systems

- The introduction of a CAREC regional transit system supported by a **CAREC guarantee** mechanism would:
  - Enhance security of the supply chain across the region
  - Help trade flow more smoothly and efficiently across borders
  - Reduce the overall cost of trade

- ✓ **Single transit declaration**
  - Design based on the T1 form of EU's NCTS
  - CAREC Advanced Transit System (CATS) prototype has been developed
- ✓ **Electronic customs-to-customs transit data exchange platform**
  - An Information Common Exchange (ICE) prototype has been developed
- ✓ **A risk-based affordable guarantee mechanism** that rewards compliant traders
  - different guarantee levels based on risks
  - Able to guarantee multiple transit movements



# CAREC Advanced Transit System (CATS) and Information Common Exchange (ICE)



## **CATS system as the user interface**

The CATS system provides a user-friendly interface for customs officials, insurers/guarantors and trade operators to interact within the pre-defined transit process.



## **ICE system as the orchestrator**

The ICE system acts as the central hub, orchestrating the exchange of information and messages related to transit process between CATS users.

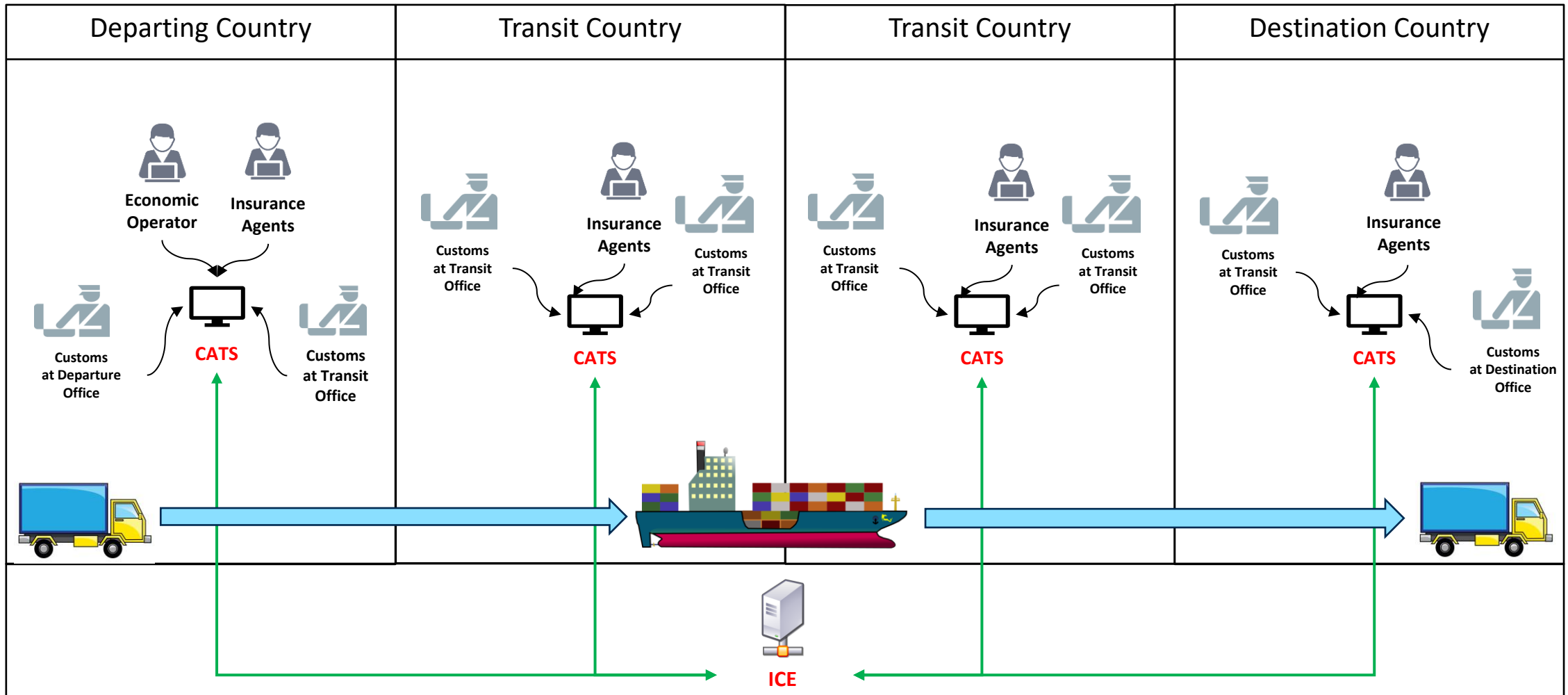


## **Harmonized message exchanges**

The ICE system ensures standardized and harmonized message exchanges between the participating CAREC member states, facilitating seamless information flow.

# Status Updates (1)

## Evaluation of the CATS/ICE Achievements, Workplan and Roadmap

- Evaluation of key milestones, progress, best practice and key lessons in 2025
- Roadmap until 2030
- Detailed workplan until 2026

## Memorandum of Understanding

- Revised draft to extend validity and include other countries
- Signed by pilot countries, Azerbaijan, Georgia, and Uzbekistan in November 2025
- New countries: Kyrgyz Republic and Pakistan
- Turkmenistan and Tajikistan in progress

# Status Updates (2)

## Multi-Country Framework Agreement (MCFA) to support the Implementation of CATS/ICE

- Draft submitted for domestic legal review in July 2025 and March 2026
- Deliberated and draft finalized in Working Group Meeting in May 2026 in Tbilisi
- Submitted for final round of domestic legal review in June 2026

## CATS/ICE Software Evolution V1 -> V2 -> V3

- Each version undergone conformity and parallel testing session.
- Version 2 and 3 testing included guarantors and economic operators
- Feedback from Customs and private sector taken into account in new versions

# Status Updates (3)

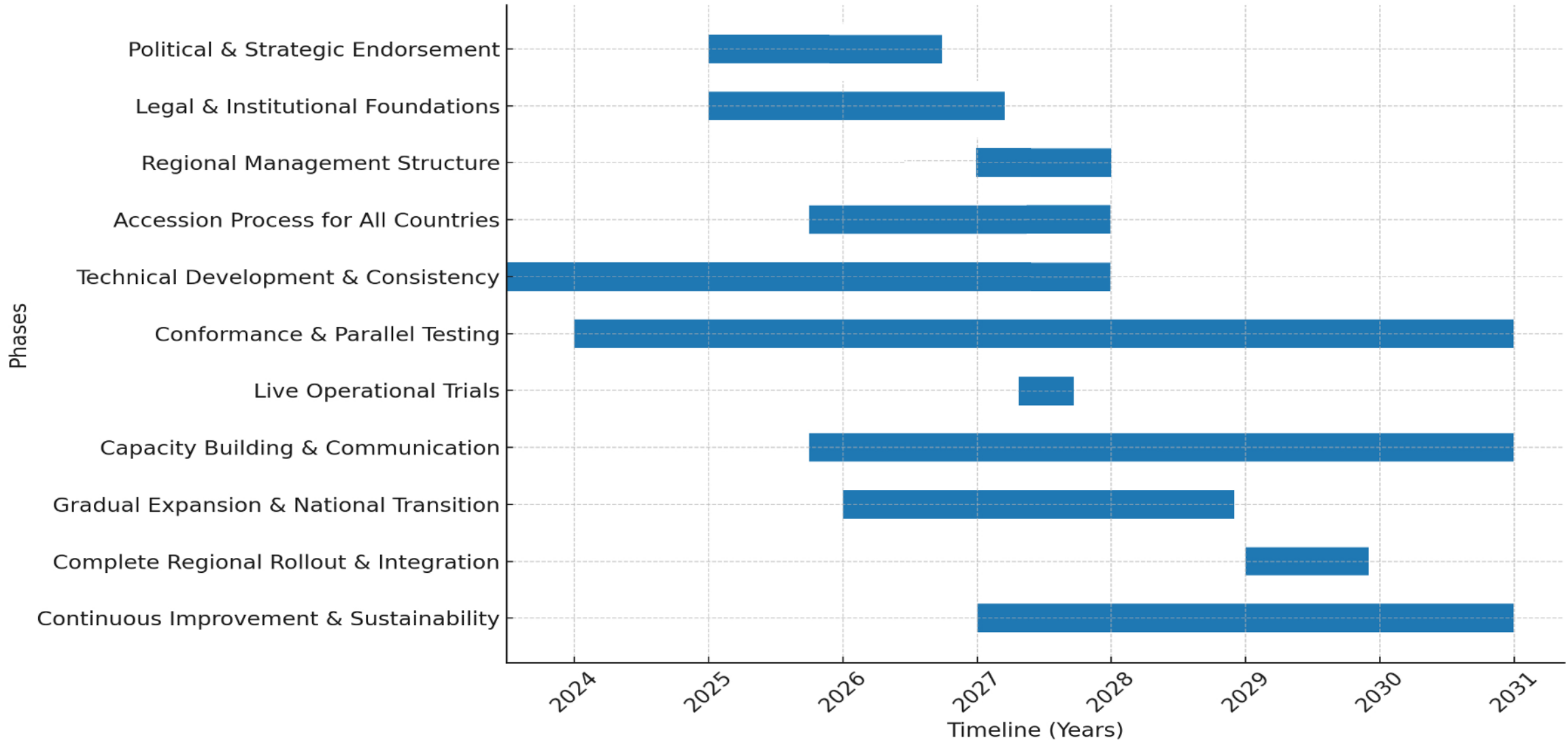
## Procedural Manuals and Training Material

- Procedural Manuals are scheduled to be developed in 2026
- Manuals for Customs, Guarantors, and Economic Operators

## Common Specifications vs Application Specifications

- Software Specifications are scheduled to be separate into mandatory Common Specifications and Application Specifications
- Common Specifications will be backed by Conformance Testing Procedures and Test Cases
