Call for regional and global partners to continue collaboration




# CAREC Partnership for Climate, Innovation and Trade


Pilot CAREC Advance Transit System and Information Common Exchange (AZE, GEO and UZB as signatories)

Participation in Global Digital Trade Platforms or Use of Emerging Technologies (IPPC's ePhyto Hub for UZB and PAK, under consideration for AZE, PRC and GEO; Artificial Intelligence in GEO customs processes; and e-certificate of Origin using blockchain for MON)
