It issues the latest policies and measures with accompanying policy interpretations and service guides, and develops application scenarios for AEO validation.

Customs District

Customs districts tailor specific AEO promotional plans and work schemes based on GACC's directives and regional characteristics, ensuring policy implementation reaches all enterprises.






