




✤ The Customs Service began its long journey of digitalization and automation of its processes and the introduction of new technologies in 2005.

✤ In 2005, before the introduction of information technology in the customs authorities of the Republic of Tajikistan, most operations and activities in various areas were traditionally carried out manually and were paperbased.




TWO INFORMATION SYSTEMS ARE USED TO CARRY OUT CUSTOMS PROCEDURES

INFORMATION SYSTEM (UAIS)

THE SYSTEM "SINGLE WINDOW TO CARRY OUT EXPORT, IMPORT AND TRANSIT CLEARANCE PROCEDURES"



UAIS OF THE CUSTOMS SERVICE





This system is a reliable, secure data transmission network, and includes the establishment of a unified infrastructure among regional structural divisions of the Customs Service and its Central Office providing access for users to central resources, including the database and the software.


UNI-PASS RISK MANAGEMENT SUBSYSTEM

INTERNATIONAL ROAD TRANSPORT (TIR)

The TIR Carnet system was adopted within the framework of the Cooperation Agreement among the Customs Service under the Government of the Republic of Tajikistan, the Association of International Road Freight Carriers of Tajikistan (ABBAT) and the International Road Union (IRU), with the attraction of investments from the Central Asia Trade Facilitation Program.






EQUIPMENT FOR CUSTOMS CONTROL

In January of the current year, the Government of the People's Republic of China provided customs control equipment to the Customs Service under the Government of the Republic of Tajikistan. This equipment was installed at customs border-crossing points and put into operation. Technical personnel at customs BCPs were trained to operate the specified equipment.





CONTROL OF VEHICLES



To control the import/export of vehicles through customs BCPs, CCTV cameras and cameras for reading license plates in real time have been installed. Control is carried out from the Central Office of the Customs Service and the records are stored in a special server.

To introduce electronic payments, within the framework of the Cooperation Agreement between the Customs Service under the Government of the Republic of Tajikistan and the Ministry of Finance of the Republic of Tajikistan, real-time data exchange on each payment transaction has been organized as envisaged for the payment of customs duties and fees , as well as their confirmation, using the non-cash system.



PROSPECTS FOR DEVELOPMENT OF THE CUSTOMS SERVICE




As part of multilateral cooperation with the World Bank and the United Nations Conference on Trade and Development (UNCTAD), with financial support from the World Bank, the ASICUDA system is planned to be adopted. This system was designed by the UNCTAD and is used in more than 90 countries around the world, thus contributing to comprehensive customs control and transparency of customs procedures in foreign trade.

This system enables to introduce digital customs operations, transparency of services, including the digitalization of customs payments using non-cash electronic payment systems, remote control of customs BCPs, pre-arrival information, etc., which is the basis for digitalization of customs agencies.

➢ 63 points to review applications from traders and issue permits are connected to the system throughout the country.

The system allows traders to submit all import, export and transit information required by regulatory authorities in a single form only once and receive 22 permits electronically through the same channel.

 \blacktriangleright It automatically considers a permit document to be issued if the deadline for consideration of the subject's application exceed the time limits as established by law.

- Automatic conversion of foreign currency to the national currency




