Section A: Methodology

A questionnaire was provided to State Revenue Committee to understand the level of digitalization, legal and technical infrastructures in place, which supports the AEO program.

The survey maps their AEO system, if any, with the 2021 WCO SAFE standards.

As reflected in the assessment report, majority of CAREC countries requested technical assistance in the following areas:

- Post validation procedures of security measures and supply chain security best practices, including on-site validation procedure, if necessary
- Raising awareness campaign within Customs
- Security and Compliance Requirements
- Post Authorization Audit, Suspension and Revocation
- Basic concepts of the AEO program
- Customs-Business Partnership and Customs-Trade Regulators (PGAs)
 partnership in extending the AEO benefits.
- Outreach with PGAs and Trading Community
- AEO Scheme for E-Commerce Shipment Actors and SMEs



Section A: Data Collection

Data collection for this survey are through the following:

- desk research of relevant materials and information
- completed surveys that were distributed to targeted respondents in coordination with the ADB AEO team and State Revenue Committee





Section B: About the Survey Questionnaire

- The questions were more about the current processes, awareness, and challenges that the SRC face in developing / managing their AEO program, including compliance with the 2021 SAFE Framework
- For continuity, the completed questionnaire (1 August 2023) provided by **Mr. Zhandos Sekenov**, Deputy Head of the Customs Operations Department, was included as part of the appendix.
- Some questions from the August 2023 survey were asked again to allow the SRC to update their responses in line with the thematic areas of this survey questionnaire.



Section C: Summary of the August 2023 Survey

- There is a senior-level support and buy-in to ensure continued support and necessary funding for its development, implementation, and maintenance.
- Outreach programs that were ticked to support the implementation of the AEO program:
 - Training about the AEO Program, such as the essential legal areas, self-assessment questionnaire, "application, verification and authorization" procedures, security and compliance requirements
 - The synergy between the AEO Program and Single Window system
 - The synergy between the AEO Program and the Integrated Risk Management

Section C: Summary of the August 2023 Survey

- There is an interest to join the AEO program pilot project with any other CAREC member country
- Date of launch was 30 June 2010
- There were three (3) certified freight forwarders, five (5) manufacturers and sixteen (16) carriers.
- The Committee is working on the mutual recognition of the AEO of the Republic of Kazakhstan
 with such countries as the People's Republic of China (hereinafter the PRC), the Republic of
 Korea and the Republic of Turkey. On April 22, 2019, a Memorandum was signed with the
 Customs Service of the Republic of Korea (in Nur-Sultan) and on April 26, 2019, a Memorandum
 was signed with the GCD of China (in Beijing)

Section C: Summary of the August 2023 Survey

- The paperless trade measures that are already in place supporting the AEO program are:
 - Electronic submission of customs declarations by the traders
 - Electronic application and issuance of Import/Export Permit, Certificates, Licenses
 - Electronic Single Window platform (TFA Article 10.4)
- More than 100 events (round tables, workshops, webinars) were held on the following topics:
 - The advantage of the AEO institute
 - Development of the AEO Institute
 - The procedure for inclusion in the AEO registry

Section D: Survey Results Discussion

- The Customs Control, Public Services, Audit and Analysis, Statistics and Risk Management Departments are involved in managing the AEO program. Further, appropriate staff are identified, dedicated, and sufficiently trained.
- There are now 29 trusted partners (5 manufacturers and 24 logistics actors)
- The state service "Inclusion in the AEO Register" is automated by the "Single Window" information system.
- There is an interest to develop the operations manual which will cover digital data governance, how to negotiate MRAs and how to use the AEO management portal.



Section D: Survey Results Discussion

- AEO pre-screening / application can easily be downloaded from their AEO website.
- The self-assessment questionnaire covers the following sections:
 - General Company Information; Information on the legal entity applying for the AEO status
 - Demonstrated Compliance with Customs Requirements
 - Satisfactory System for Management of Commercial Records (e.g., accounting and logistical system)
 - Financial Viability; Cargo Security (e.g., inspection of cargo conveyance, container seals)
 - Conveyance Security; Premises Security; Personnel Security and Information Security



Section E: Mapping AEO program vs. 2021 SAFE

- Assess the compliance with the 2021 WCO SAFE Framework
- Establish a voluntary certification program, initially for selected economic operators, consistent and aligned with international best practices. It will be administered by the Customs Authority to help certain economic operators in the international supply chain adopt acceptable control measures to enhance the security of such chain
- Enhance Customs-Business, Customs-Customs and Customs-PGA partnerships on trade security and trade facilitation based on trust and mutual respect
- Establish accreditation procedures that offer certain benefits and incentives to certain economic operators considered as trusted allies




Recommendations
