

SPECIAL FACILITATION MEASURES FOR TYPE 1 AEOs:

- **1.** Carrying out customs operations as a matter of priority ;
- 2. No requirement to provide security for payment of customs fees and duties in case of transit of goods, which are delared by an AEO;
- 3. No requirement to provide security for payment of customs fees and duties upon release of goods, which are declared by an AEO;
- 4. Release of goods before submitting a goods declaration;
- 5. Performing customs control if it is assigned in the form of a customs inspection or a customs examination as a matter of priority ;
- 6. Recognition by customs authorities of seals attached by the AEO to freight spaces (compartments) of vehicles or their parts as means of identification;
- **7.** No requirement to specify the route of transportation of goods in relation to goods transported by an AEO;
- 8. Priority participation in pilot projects and experiments conducted by customs authorities;
- **9.** Carrying out by a carrier who is an AEO certain operations with goods (unloading, reloading, etc.) without the permission of the customs authority or without notifying it.

FACILITATION MEASURES FOR TYPE 2 AEOs:

- **1. Temporary storage** of AEO's goods **in AEO's buildings, premises and (or) open areas**;
- 2. Temporary storage in AEO's buildings, premises and (or) open areas, of goods of persons who are not AEOs (if provided for by the legislation of the member states);
- **3. Delivery of goods** to the customs control area established in AEO's buildings, premises and (or) open areas, **carrying out customs control and performing customs operations**,
- 4. Carrying out customs control in AEO's buildings, premises and (or) open areas;
- 5. Carrying out customs operations related to customs declaration and release of goods;
- 6. Carrying out customs control if it is assigned in the form of a customs inspection or a customs examination as a matter of priority;
- 7. Applying AEO's identification tools used by customs authorities;
- 8. No requirement to provide security for payment of customs fees and duties upon release of goods, which are declared by an AEO;
- 9. Release of goods before submitting a goods declaration;
- **10.** No requirement to provide security for payment of customs fees and duties when deferring the payment of import customs duties, if the AEO acts as a declarant of goods.

Type 3 certificate entitles the AEOs to enjoy special facilitation measures as specified in the certificates of types 1 and 2
